School social workers are empowered within a coherent framework to guide advocacy efforts and service delivery.

The purpose of this toolkit is to provide resources for state associations and school social workers to promote and pass legislation acknowledging NCSSW™ as an equivalent standard to teachers and other professional national certifications. NATIONAL SCHOOL SOCIAL WORK CERTIFICATION

National Certified School Social Worker™ (NCSSW) is an advanced certification awarded through the School Social Work Association of America (SSWAA) to school social workers who demonstrate mastery of the National School Social Work Practice Model competencies.

WHY IS IT IMPORTANT?

National Certification enables School Social Workers to demonstrate the skills and competencies needed for the provision of high-quality services in schools. NCSSW™ is designed to promote consistency, to guide graduate education, credentialing, and professional practice, as well as the evaluation of services. School social workers are empowered within a coherent framework to guide advocacy efforts and service delivery.

IMPACT

National certification is an indication of a highly qualified professional that:

- Recognizes the mastery of the National School Social Work Practice Model competencies
- Implements nationally recognized school social work standards
- Promotes best practices in SSW service delivery to students, families, schools, and communities
- Demonstrates commitment to impacting social, emotional, behavioral, mental health, and academic outcomes
- Acknowledges dedication to equity, social justice, and access to quality education to ensure all students have the opportunity to succeed
- Recognizes the School Social Work National Certification as an equivalent national certification to other education professions

TAKE ACTION

- Propose legislation that recognizes the School Social Work National Certification as equivalent to the National Board Certification for Teachers, School Counselors, and School Psychologists
- Work with your school district and state department of education to recognize national certification as the common standard for advanced school social work practice

Renewal Requirements			
<p>The National Certified School Social Worker™ is valid for 3 years. Prior to the expiration date, the NCSSW™ must submit an application for renewal, with proof of maintaining membership in SSWAA at the Full or Premiere level, proof of licensure or certification at the Masters level in social work/school social work required to practice school social work in that state, and proof of continuing education units earned over the 3 year period.</p> <p>NCSSWs that qualify for renewal will need to submit and pass reflection statements and artifacts for two of the nine school social work model competencies in a recertification course.</p>	<p>NBCT achieved before 2017 is valid for a period of 10 years. Certifications after 2017 are valid for a period of 5 years. The National Board has revised its policy from renewal to Maintenance of Certification (MOC). Section 4: National Certification for School Social Work Sample Legislation

When discussing legislation, it can be helpful to provide a starting point for legislators to guide the direction of the bill. When we ask for something without providing guidance, it can be driven by other groups whose interests might not align with ours. Below are two samples that can be used as a starting point for NCSSW™. The first version is for states that do not recognize any professional national certification. The second version is for states that recognize other educational professions but do not currently include school social work.

Version 1: For a state with no current legislation supporting national certification for any educational professional

A BILL FOR AN ACT CONCERNING STIPENDS FOR NATIONAL BOARD-CERTIFIED EDUCATORS.

Current law requires the Department of Education (department) to award an annual stipend of *[Insert Stipend Amount]* to teachers, school counselors, principals, school psychologists, school librarians, and school social workers who hold national board certification and who are employed by a school district, board of cooperative services, area education agency, a charter school of a school district, or an institute charter school (local education provider).

The department shall award an additional *[Insert Stipend Amount]* annual stipend to teachers, principals, school counselors, school psychologists, school librarians, and school social workers who are employed in a low-performing, high-needs school. The additional *[Insert Stipend Amount]* stipend is also extended to teachers, school counselors, school psychologists, school librarians, and school social workers (national board-certified educators) who are employed in a rural school district.

If a national board-certified educator transfers employment from one low-performing, high-needs school or rural school district to another low-performing, high-needs school or rural school district, the educator remains eligible for the additional stipend. However, if a national board-certified educator leaves employment with a low-performing, high-needs school or rural school district, the educator is no longer eligible for the additional stipend.

If there are insufficient funds, the department shall reduce the amount of each stipend by the same percentage that the deficit bears to the amount required to fully fund the total number of national board-certified educators who qualify for the stipend. A national board-certified educator who is employed as a principal or an administrator in a school and maintains a national certification is eligible for a stipend.

A nationally certified school social worker is defined as a certified school social worker who also holds a certification from the National Association of Social Workers or the School Social Work Association of America.

As used in this section, unless the context otherwise requires:

- a. "local education provider" means *[Insert state's definition]*

- b. "national board-certified educator" means: beginning with the *[insert next budget year]* budget year
 - a. teachers who hold a certification from the national board for professional teaching standards;
 - b. school counselors who hold a certification from the National Board for Certified Counselors;
 - c. nationally certified school psychologists who hold a certification from the National Association of School Psychologists;
 - d. school librarians who hold a certification from the national board for professional teaching standards, and
 - e. nationally certified school social workers who hold a certification from the National Association of Social Workers or the School Social Work Association of America.

Version 2: For a state with current legislation supporting national certification for educational professionals other than school social workers,

Add to the list of eligible professions or anywhere specific professions are mentioned:
"and school social workers."

Add to definitions the following language: "A nationally certified school social worker is defined as a certified school social worker who also holds a certification from the National Association of Social Workers or the School Social Work Association of America."

Section 5: National Certification for School Social Work Sample Letter to Legislators

The letter below provides a sample that can be utilized for associations and individual school social workers to send to state legislators asking for support in NCSSW™. It might also be helpful to engage other education professionals in sending letters to support national certification, especially where no professional recognition exists.

Where current national certification exists,

I am *[Insert name]*, an *[Insert State Association]* member. As you know, we are facing a school personnel shortage nationally and in *[Insert state]*. This shortage includes our Specialized Instructional Support Personnel (SISP), representing our school social workers, school counselors, and school psychologists. At *[Insert State or District]*, we cannot replace the number of school social workers and school psychologists at the rate they are retiring or leaving our district. To recognize, recruit, and retain highly qualified professionals in *[Insert State's]* schools, *[Insert State Association]* is proposing establishing a “national board certification compensation program” for school social workers, school psychologists, and school counselors that mirrors the current *[Insert State]* teacher national board certification recognition and stipend program, *[Insert Current State Law or Educational Code]*. National certification is an advanced certification awarded to professionals who demonstrate mastery of their professional competencies through their respective national associations. With a system already in place in Iowa for national teacher certification, the resources needed to establish and implement the recognition and compensation for our SISPs would be minimal. The impact, however, of having national certification recognition and compensation for SISPs in *[Insert State]* will have significant long-lasting implications for our schools, students, and families as more SISPs obtain the high standards of being nationally certified.

I would like to know if you are willing to commit to creating a national certification parity for our Specialized Instructional Support Personnel (SISP) that mirrors the current teacher program for school social workers, school psychologists, and school counselors. For FY 2023, an increase in the Student Achievement and Teacher Quality Program appropriation of *[Insert Amount]* is requested. The new funds for our highly qualified school social workers, school psychologists, and school counselors who hold national certifications would be made available on the same basis as the current program.

National certification parity is one step we can take now that would immediately impact recognizing, recruiting, and retaining our highly qualified Specialized Instructional Support Personnel in *[Insert state]* schools.

Where no current national certification exists,

The resources needed to establish and implement the recognition and compensation for our teachers, school librarians, and SISPs should be allocated in the state budget in the amount of *[Insert Amount]*. The impact, however, of having national certification recognition and compensation for these highly trained professionals in *[Insert State]* will have significant long-lasting implications for our schools, students, and families as more educational professionals obtain the high standards of being nationally certified.

I would like to discuss your willingness to introduce legislation that supports a national certification recognition and compensation program for our nationally certified educational professionals. For FY *[Insert year]*, an appropriation of *[Insert Amount]* is requested.

National Certified School Social Worker™

The School Social Work Association of America (SSWAA) is a non-profit, professional membership organization that offers National Certification for School Social Workers™ (NCSSW™). National certification does not replace entry-level certification required by most state departments of education to enter the field. Instead, it is advanced certification that indicates that a school social worker has mastered competencies described in the National School Social Work Practice Model.

The SSWAA School Social Work Practice Model describes the skills and services needed for the delivery of high-quality social work services in schools. The model is designed to promote consistency, to guide graduate education, credentialing, and professional practice, as well as the evaluation of services. The model further empowers school social workers with a coherent framework to guide advocacy efforts and service delivery decisions. Adherence to the model is essential to qualify for national certification.

National Certified School Social Worker™ (NCSSW™) is awarded through SSWAA to identify school social work professionals who have voluntarily sought and obtained an advanced certification that demonstrates mastery of competencies of the SSWAA National School Social Work Practice Model.

1 National Certified School Social Worker TM

1. ***How will candidates benefit from national certification?*** National Certification should be recognized as the common standard for advanced school social work service provision. While each state has its own licensure tests and standards, the SSWAA National Certification will demonstrate an advanced level of understanding and expertise in School Social Work, equivalent to the National Board Certification for Teachers, School Counselors, and School Psychologists.
2. ***How is National Certified School Social Worker TM different from my state social work license or state school social work license/certification?*** National Certified School Social Worker TM is an advanced certification that is both post-MSW and requires four (4) years of experience in the field as a school social worker or school social work Educator. This is not an entry level certification such as the one required in the candidate's state for social work practice or to become a school social worker.
3. ***How is National Certified School Social Worker TM different from NASW's Certified School Social Work Specialist (C-SSWS)?*** The C-SSWS was developed to fill the gap for states whose state Department of Education does not offer licensure or certification for school social workers. It was created as an entry-level certification requiring two years of supervised experience as a school social worker. SSWAA's National Certified School Social WorkerTM is an advanced certification for school social workers with four years post-Masters experience in the field.
4. ***Why get certified?*** School social workers have an opportunity to help shape the future of the field. Advanced certification for school social workers will make us more visible, viable and valued in an education setting where national advanced certification is recognized and rewarded. You have the opportunity to be the first in your district, or in your state, to demonstrate your advanced skills by earning a nationally recognized certificate and to use that certification to bring the profession of school social work to the level of other national certification programs, in contract negotiations and equitable compensation.



2 Application Process

5. **How much does SSWAA National Certification cost?** \$250 is the cost to become an NCSSW Candidate. With your NCSSW Candidacy you will have a one (1) year timeframe to complete all competencies required for certification.
6. **Do I have to be a member of SSWAA?** Yes, to become a candidate for national certification you need to be a member at the full or premiere level. For SSWAA membership prices and information go to <https://www.sswaa.org/sswaa-membership>. To maintain your national certification, you will need to maintain your membership each year.
7. **What are the requirements for application to be a candidate for national certification?**
Candidates must have:
 1. Have an MSW from a CSWE accredited social work program.
 2. At least 4 years post-MSW experience as a School Social Worker or SSW educator in higher education
 3. Current active licensure or certification required in the state for a school social work position. Licensure as a Master's Level Social Worker will be considered in lieu of DOE licensure in state's in which there is no requirement for school social workers. This licensure will be considered in conjunction with the years of experience requirement.
 4. Active SSWAA membership at the Full or Premiere level
8. **How do candidates apply for national certification?** Go to <https://www.sswaa.org/national-certification> scroll down the page and click on "Apply Register Today".
 1. **Fill out the registration form** and log in as necessary (Please note you must have an active membership to apply. If you are not a member join SSWAA first as a Full or Premiere member then return to this page). Select "pay by invoice" and submit.
 - i. **What do I need for the Application:**
 - **Employer Verification** (note: sample employment verification form is available)
 - **Current Resume**
 - **Copy of your licenses/certifications**
 - **Brief Bio (400 characters or less)**
 - **Professional headshot**
 - **Cover letter**
 - ii. **Watch for a confirmation email** which will contain a link to the application form.
 - iii. **Once your application has been reviewed and approved you will receive an email** regarding approval and will be asked to pay the registration fee via invoice.

3 National Certification Process

9. **How long do I have to complete the national certification portfolio process?** You have one year upon approval in the course to complete the process. If you have any questions about your start date, email pdlearning@sswaa.org to confirm that date.
10. **How many competency statements with supporting artifacts do I need to submit?** Nine competencies are required with supportive artifacts, to match the nine competencies associated with the National School Social Work Practice Model



11. **Which version of the National School Social Work Practice Model will I be using for this process?** The National Model will be updated as needed. Candidates will focus on the model that is in use by SSWAA at the time they become a candidate for national certification.
12. **How long does it take to complete one competency statement?** This depends on whether the candidate has already implemented activities that demonstrate skills measured in the performance indicators or if they need to implement them prior to writing the reflection statement and submitting artifacts. This also depends on the time the candidate can commit to identifying artifacts and writing the statement. In general, candidates shared that it takes about 10 hours to write one competency statement.
13. **Do the nine competencies have to be completed in order?** No, candidates may submit their reflection and artifacts in any order.
14. **How soon are competency statements and artifacts rated following submission?** Reviewers have committed to providing candidates feedback within two weeks of submission.
15. **Do I need to submit all nine of the competency statements and artifacts before receiving feedback from reviewers?** No, candidates may submit one reflection statement with artifacts at a time, await feedback, then submit another reflection statement with artifacts and/or submit as many as they want at one time.
16. **What happens at the one-year point if a candidate does not complete the national certification process?** Prior to the year's end, the candidate can submit a request to continue, explaining why they were unable to meet the one-year deadline. The SSWAA Committee will review the request and make a determination as to whether or not to allow an extension. If an extension is approved, the candidate will pay a \$50 fee to continue for another year. If the request is denied, an appeals process is available. This would require sending a letter to the SSWAA Professional Development Committee who makes a recommendation to the SSWAA Board.

4 National Certification Course

17. **Will I interact with my colleagues during this course?** Interaction with NCSSW Candidate peers is optional. There is an opportunity to post on the discussion board to share tips or ask for tips from other candidates. There is also a Facebook page for candidates to interact. Information about the Facebook page is included in an email candidates receive after being accepted to the process.
18. **What support is available to candidates during the national certification process?** The raters are available to support you through 1:1 meetings, small group meetings of interested candidates, or in other ways you deem would be helpful in the process. 5 National Certification Renewal

19. **How often does the SSWAA National Certification need to be renewed?** National School Social Work Certification™ lasts for 3 years and will need to prior to the end of Year 3. Instructions for recertifying are provided at <https://www.sswaa.org/national-certification>.
20. **What does a National Certified School Social Worker™ need to do to maintain certification?** A National Certified School Social Worker™ needs to maintain membership in SSWAA at the full or premiere level and maintain a state social work/school social work license or certification. If the state school social work or social work license/certification(s) do not require earning CEUs each year, the NCSSW will need to track the earning of 10 CEUs per year (30 CEUs total) for the recertification process.
21. **What do I need to do to renew the certification?** To renew certification, National Certified School Social Workers will need to pay a \$100 renewal fee and submit two (2) competency statements and artifacts to demonstrate mastery of two of the nine competencies in the years since certification.

6 SSWAA and National Certification

22. **What is SSWAA doing to create value around certification?** The SSWAA Legislative Committee along with the Standards and Practice committee are developing a toolkit to help both state school social work associations and individual school social workers promote the value of national certification for the profession to their district and state legislators. Watch for the availability of that toolkit.
23. **What can state associations do to create value around certification?** While SSWAA is developing a toolkit for state associations, it will be up to the state associations to engage their members in moving forward amendments to state legislation/regulations to recognize SSWAA National certification as equivalent to NASP, ASCA and NBPTS national certification.
24. **What can I do to create value around certification?** While SSWAA is developing a toolkit for individual members, it will be up to the individuals to engage their school district in moving forward amendments to policies to recognize SSWAA National certification as equivalent to NASP, ASCA and NBPTS national certifications.
